### **Business Organizations**

The business organizations will be strategically restructured to respond new social needs and challenges, as well as to further promote business portfolio management and expansion. The business organization structure will be changed to enable each Business Division to accelerate the shift towards key focus business domains and high-growth sectors, by consolidating operating segments and expanding the operational scope of each Business Division.

- The Business Divisions will be reorganized from 16 divisions into 10 divisions.
- The Business Groups and the Business Administration Department of each Business Group will be eliminated.
- The position of Chief Executive Officer of each Business Group will be changed to Member of Corporate Management Committee, Supervisor of each Business Division. Member of Corporate Management Committee, Supervisor of each Business Division will support the President and CEO, ensure Business Divisions align with Marubeni's corporate strategy, provide guidance, and support each Business Division as executive management officers.
